TITLE 59 CHAPTER 33 SEC 1335.1

It shall be unlawful for any principal, person in custody, or defendant, or indemnitor to provide false information, including identity and physical address, on any undertaking or indemnification agreement. Violation of this section shall be a misdemeanor punishable by imprisonment in the county jail for a term of not more than one (1) year, or by a fine of not more than one thousand dollars (\$1,000) or by both such imprisonment and fine.

TAYLOR VS TAINTOR, 83 US 366- 1872 US SUPREME COURT

When bail is given, principal is regarded as delivered to the custody of his sureties. Their dominion is a continuance of the original imprisonment. Whenever they choose to do so, they may seize him up and deliver him up in their discharge and if that cannot be done at once they may imprison him until it can be done, in person or by agent. They may pursue him into another state; may arrest him on the Sabbath; and, if necessary, may break and enter his house for that purpose. The seizure is not made by virtue of new process. None is needed. It is likened to the re-arrest by the sheriff of an escaping prisoner. TITLE 21 CHAPTER 12 SEC 440

Any person who shall knowingly feed, lodge, clothe, arm equip in whole or in part, harbor, aid, assist or conceal in any manner any person guilty of any felony, or an outlaw, or fugitive from justice, or any person seeking to escape arrest for any felony committed within this state or any other state or territory, shall be guilty of a felony punishable by imprisonment at hard labor in a state penitentiary for a period not exceeding ten (10) years.
